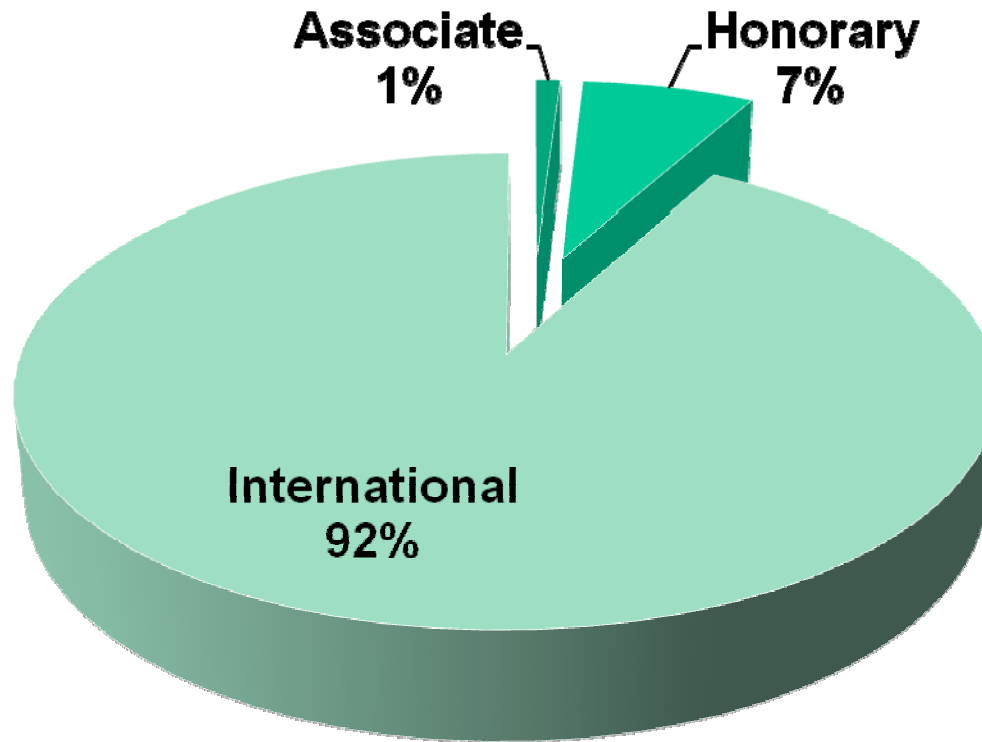

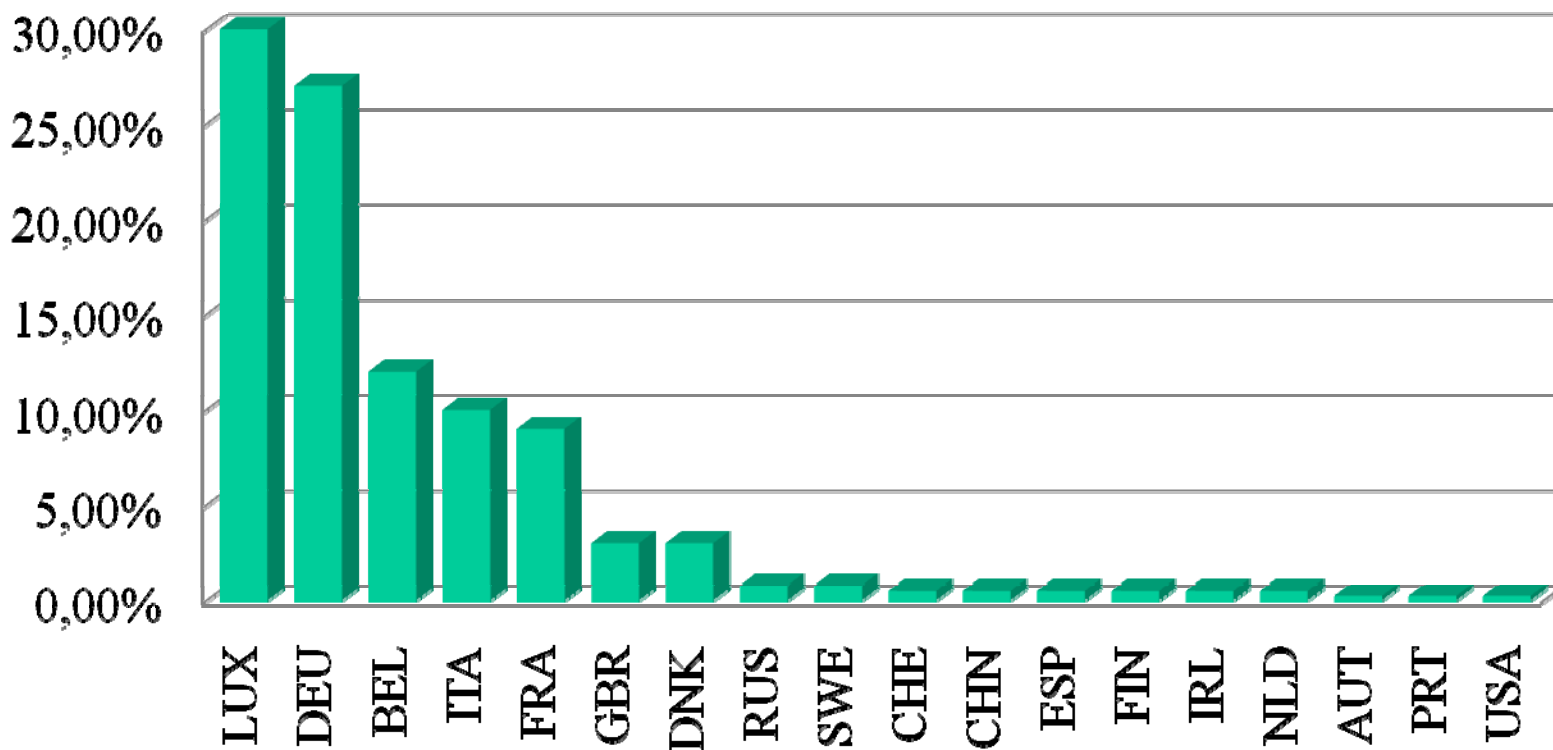
Members Status





Members Nationality

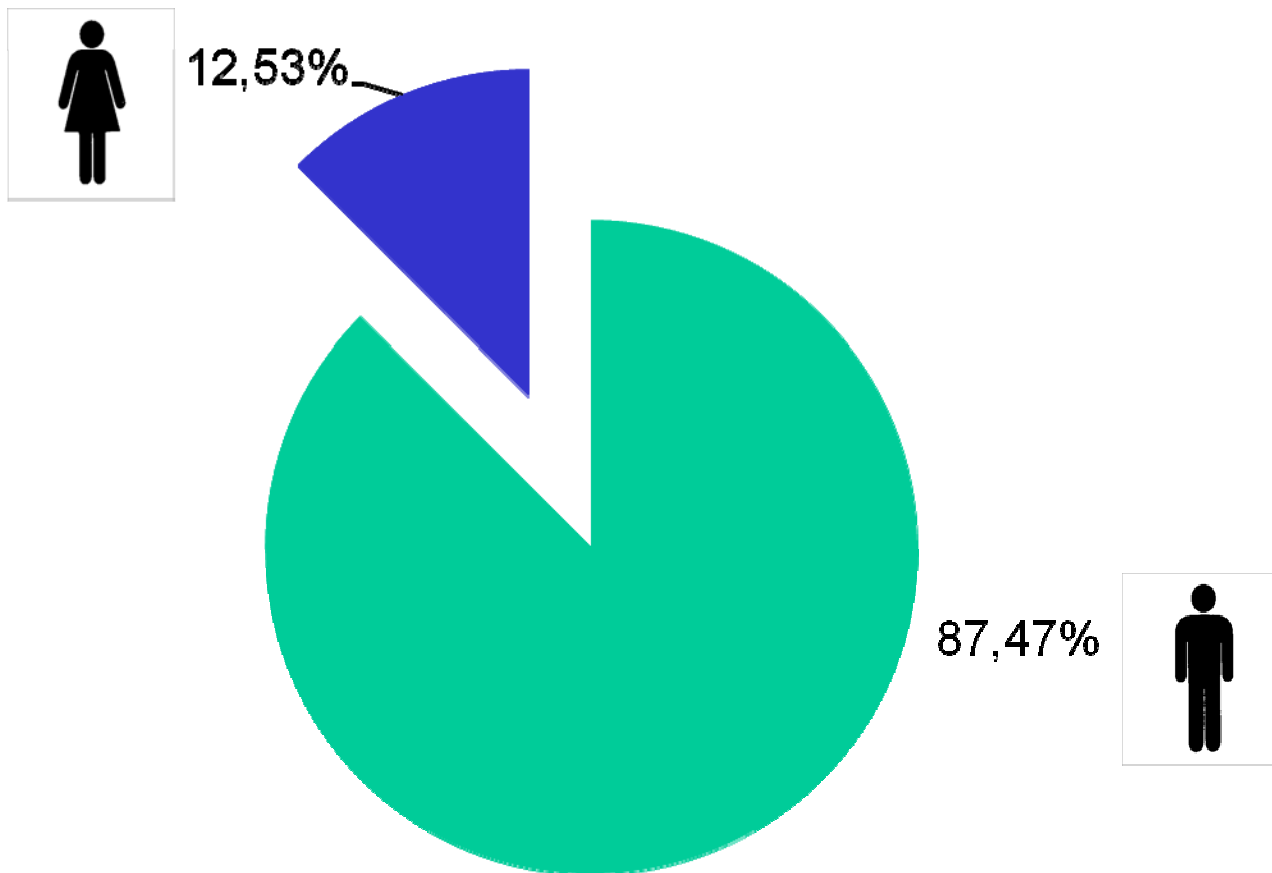

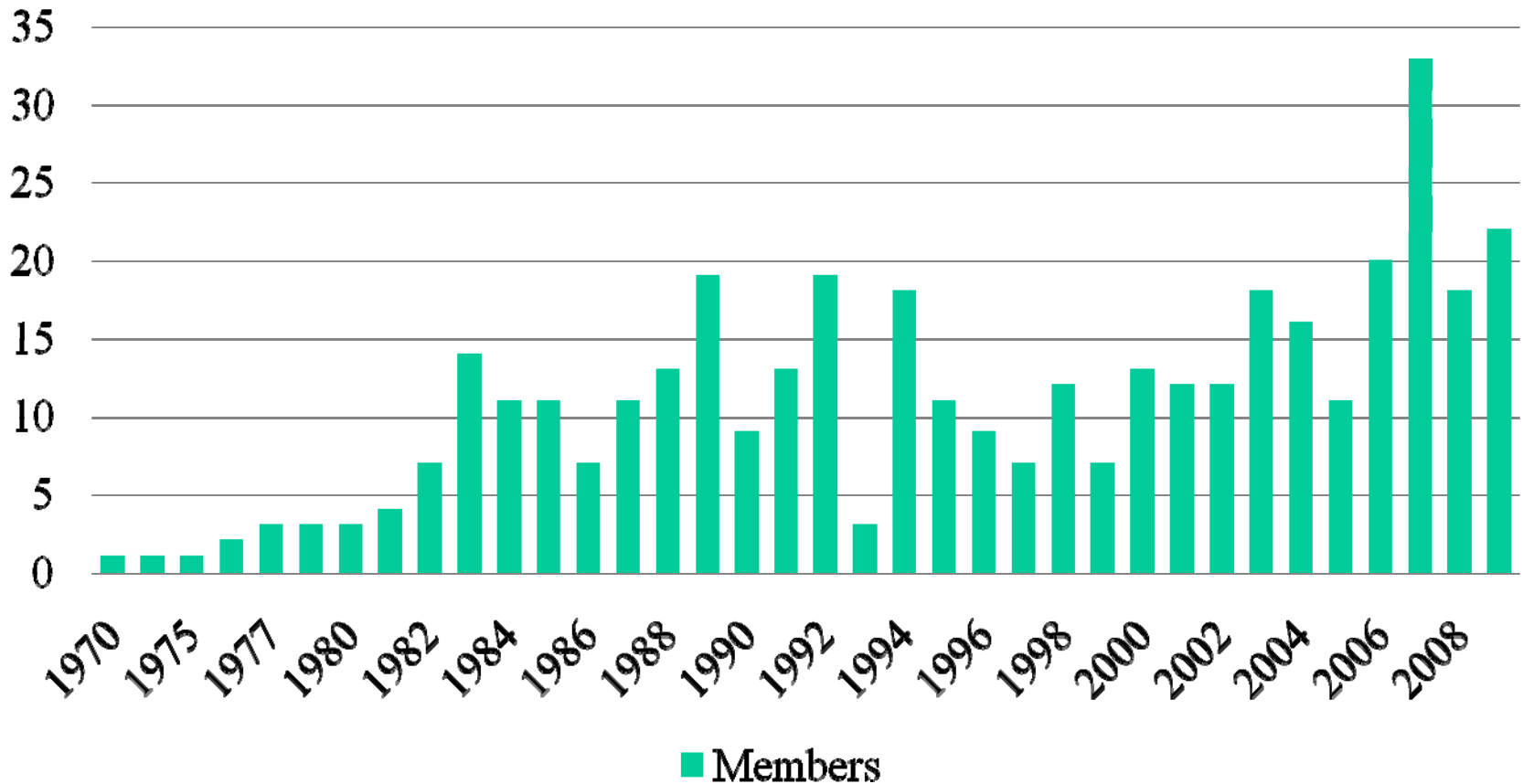

Members Distribution



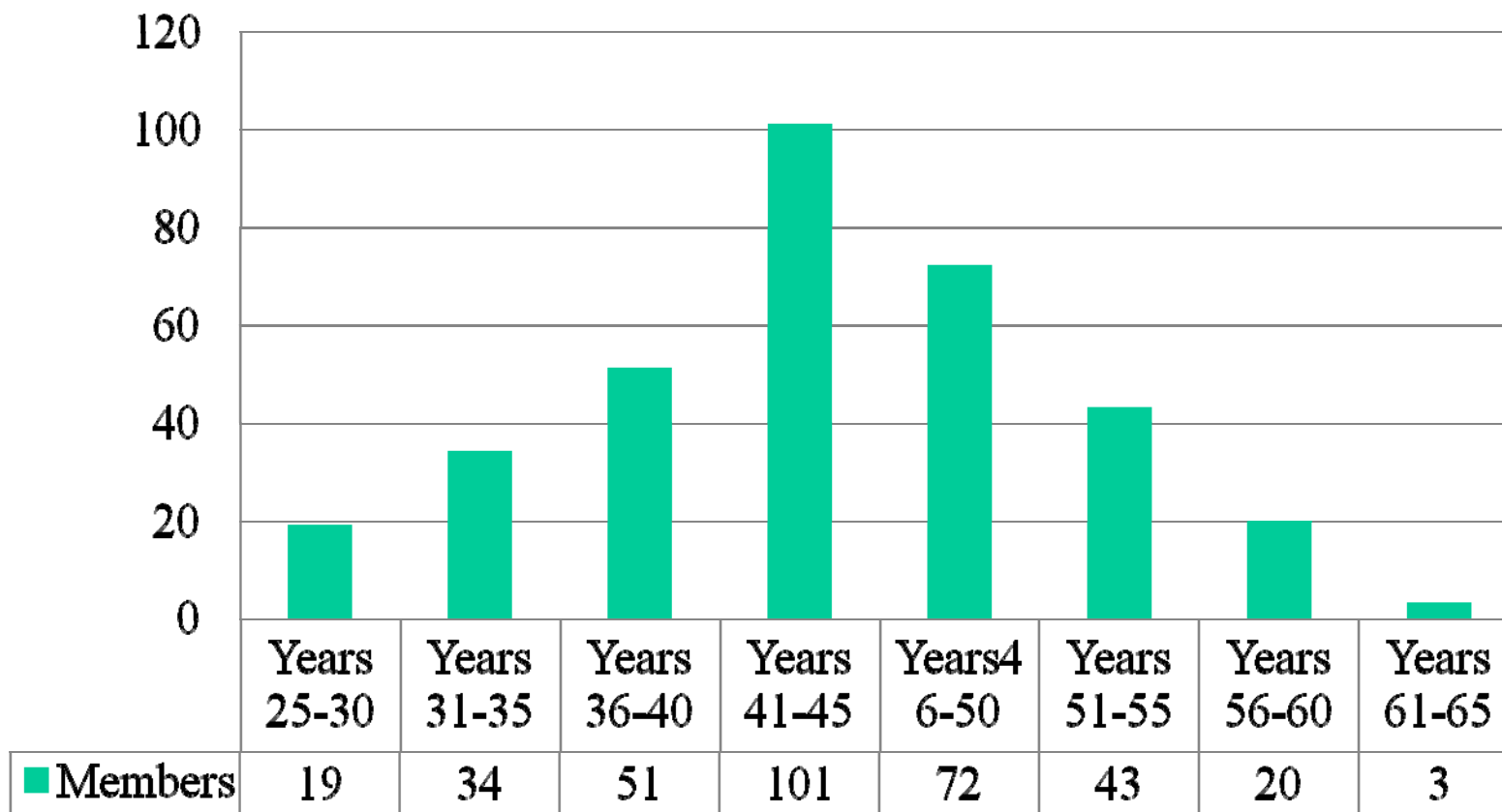
Members Inscription Year

Persons still members of ACI



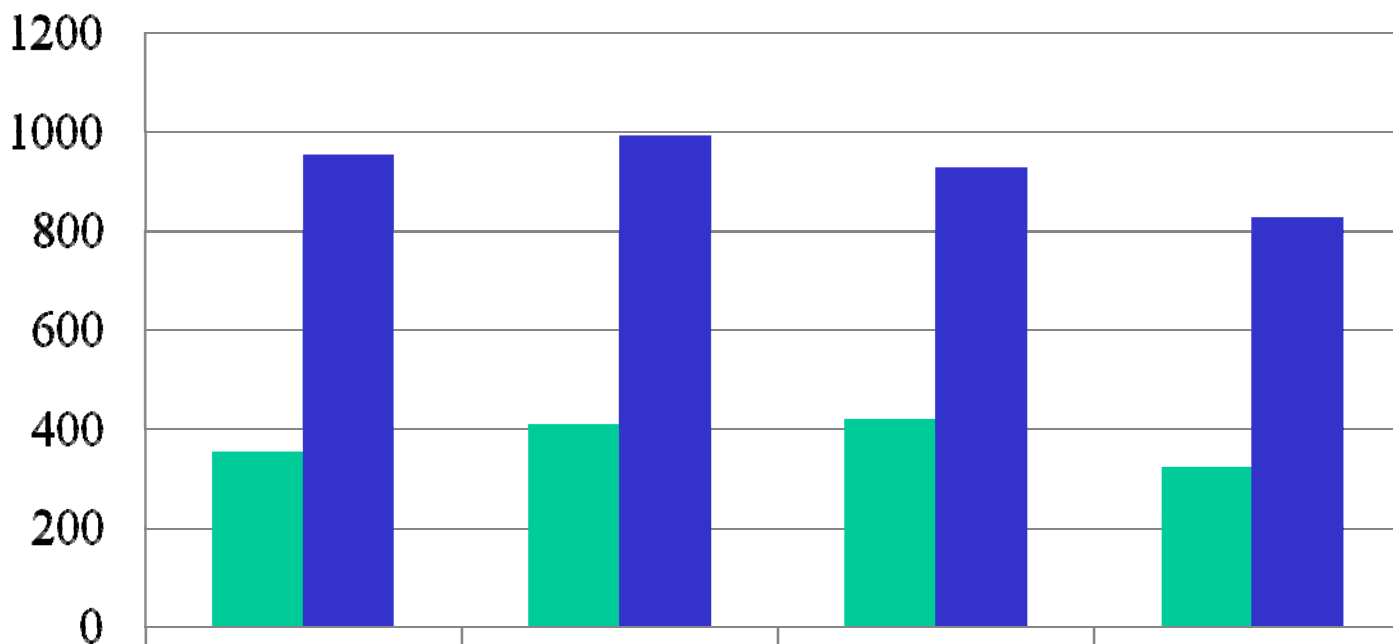


Age of our Members





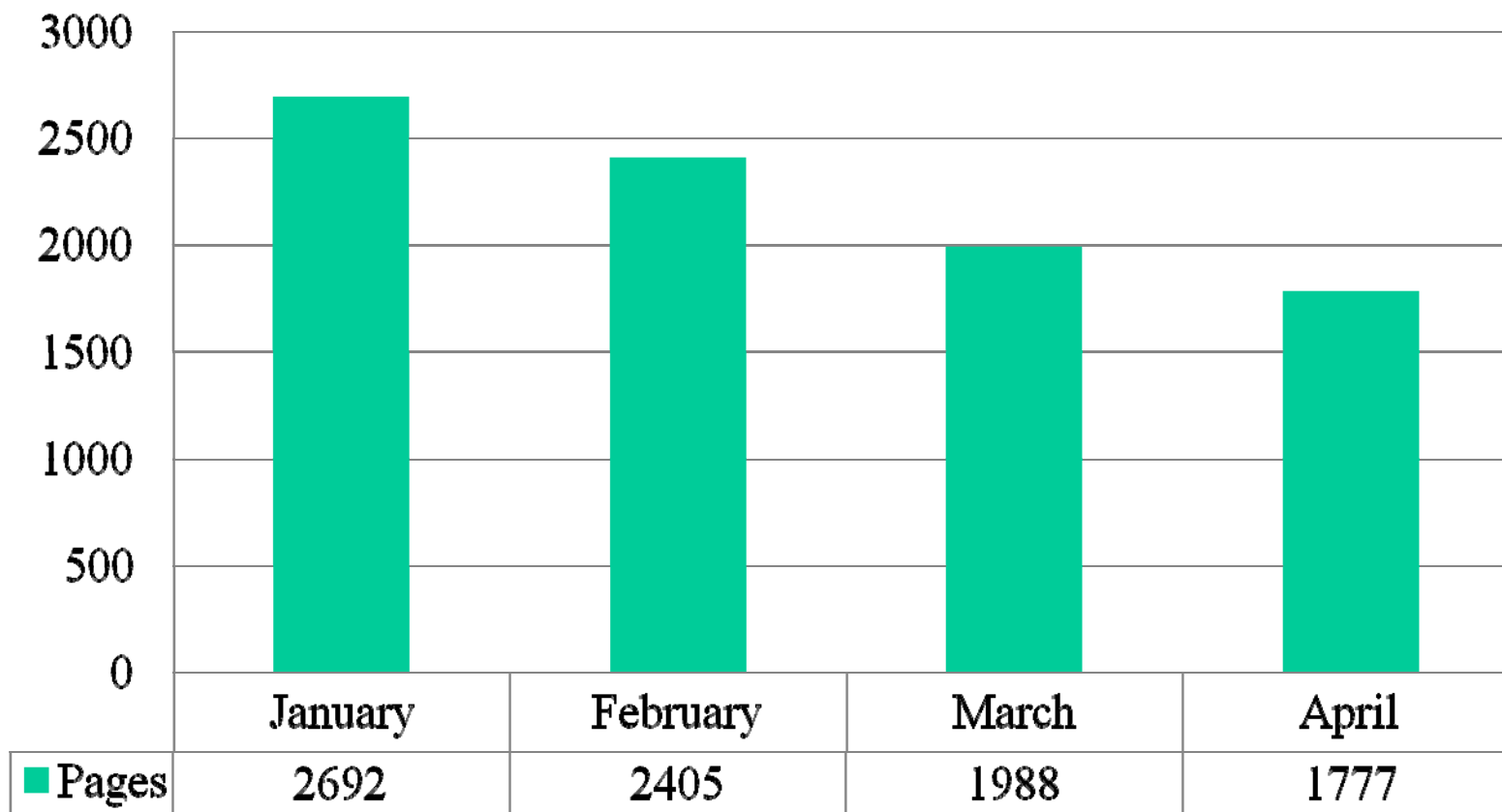
